Dear ECU Customer:

Easley Combined Utilities requires that all backflow prevention devices, including those on lawn irrigation systems, be tested each year for proper operation, and to ensure that the potable water system is protected from possible contamination.

Your backflow prevention devices can be tested by an outside contractor that is certified by the South Carolina Department of Health and Environmental Control. Attached to the back of this letter is a list of testers that provide these services.

A report indicating the results of the test must be provided to Easley Combined Utilities. Test results for all backflow prevention devices must be received on or before **Friday 8/7/20** to prevent disconnection of service. These results may be dropped by our main office at 110 Peachtree St. Easley SC, emailed to bellenburg@easleyutilities.com, or faxed to 864-855-8115.
